

ORDINANCE NO. 1985- 4

AN ORDINANCE AMENDING ORDINANCE 78-1  
AS PREVIOUSLY AMENDED BY ORDINANCE 83-1

BE IT ORDAINED, by the Board of Commissioners of the County of Floyd, that Floyd County Ordinance No. 78-1, as amended by Floyd County Ordinance No. 83-1, be further amended in the following particulars:

Subparagraph (c), Paragraph 2, Floyd County Ordinance No. 78-1 be, and the same hereby is, amended to read follows:

(c) Bring in or dump, deposit or leave any bottles, broken glass, ashes, paper, boxes, cans, dirt, rubbish, waste, garbage, refuse or other trash. No such refuse or trash shall be placed in any waters in or contiguous to any park, or left anywhere on the grounds thereof. Each person, firm, or corporation using the public parks and grounds shall clean up all the referenced materials and place same in the proper receptacles where these are provided; where receptacles are not provided, all such rubbish or waste shall be carried away from the park by the person responsible for its presence, to be properly disposed of elsewhere.

Subparagraph (b), Paragraph 4, Floyd County Ordinance No. 78-1 is amended by the alteration of the vehicular speed limit from 15 MPH to 20 MPH.

Subparagraph (c), Paragraph 4, Floyd County Ordinance No. 78-1, be, and the same hereby is, amended by the addition of the following prohibition:

It shall be unlawful to abandon any animal life within the park boundaries.

Paragraph 4, Floyd County Ordinance No. 78-1 is amended by the addition of the following paragraph:

(g) Hours of closing: No person shall be permitted to remain, stop or park within the confines of any park, parkways, or other areas regulated by the New Albany-Floyd County Department of Parks and Recreation during the following hours: City Park Properties - 10:30 P.M. until 6:00 A.M.; County Park Properties - 10:30 P.M. until 6:00 A.M. All times shall be deemed to be prevailing local time, Floyd County, Indiana. Exceptions to the foregoing time limitations are emergencies, with special

permits, or during events sponsored or approved by the New Albany-Floyd County Department of Parks and Recreation.

In all other respects, Floyd County Ordinance No. 78-1, as previously amended by Floyd County Ordinance No. 83-1, remains in full force and effect as originally drafted and written, and this Amendment thereof shall be in full force and effect from and after its passage and approval by the Board of Commissioners of the County of Floyd.
