

FLOYD COUNTY ORDINANCE 1995-2  
AN ORDINANCE ALTERING THE BOUNDARIES OF CERTAIN VOTING  
PRECINCTS IN FLOYD COUNTY, INDIANA

WHEREAS, the Civil City of New Albany, Indiana, and the towns of Georgetown and Greenville located in Floyd County, Indiana, have annexed certain of the unincorporated areas of said county; and

WHEREAS, the provisions of I.C. 3-11-1.5-4 dictate that the Board of Commissioners of the County of Floyd alter the existing boundaries of certain voting precincts to recognize the annexation of territory by said city and towns; and

WHEREAS, the Board of Commissioners of the County of Floyd has directed the Floyd County Engineer to prepare and file with the State Election Board descriptions, maps, and summary sheets pertaining to the altered boundaries of certain voting precincts located in Floyd County, Indiana; and

WHEREAS, by Floyd County Ordinance 1994-FC0-XIII, the Board of Commissioners of the County of Floyd amended the boundaries of certain precincts located in Floyd County, Indiana; and

WHEREAS, the Board of Commissioners of the County of Floyd is desirous by this Ordinance of establishing the boundaries of certain voting precincts located in Floyd County, Indiana, to include those previously set forth in Floyd County Ordinance 1994-FC0-XIII, all as hereinafter provided.

NOW THEREFORE:

BE IT ORDAINED, that the boundaries of the following precincts in the Civil City of New Albany, Indiana, and New Albany Township be, and they hereby are, established, altered or amended to conform with the descriptions, maps, and summary sheets heretofore filed with the State Election Board, which maps, descriptions, and summary sheets are incorporated herein by reference and made a part of this Ordinance:

Precinct Number 28-A	Precinct Number 29-A

BE IT FURTHER ORDAINED, that the boundaries of the following precincts in the Town of Greenville, Indiana, and Greenville Township be, and they hereby are, established, altered or amended to conform with the descriptions, maps, and summary sheets heretofore filed with the State Election Board, which maps, descriptions, and summary sheets are incorporated herein by reference and made a part of this Ordinance:

Greenville 1  
Greenville 3  
Greenville 5

Greenville 2  
Greenville 4

BE IT FURTHER ORDAINED, that the boundaries of the following precincts in the Town of Georgetown, Indiana, and Georgetown Township be, and they hereby are, altered and amended to conform with the descriptions, maps, and summary sheets heretofore filed with the State Election Board, which maps, descriptions, and summary sheets are incorporated herein by reference and made a part of this Ordinance:

Georgetown 5

Georgetown 2  
Georgetown 4

BE IT FURTHER ORDAINED, that a copy of this Ordinance shall be filed with the State Election Board no later than seven days following its passage as required by the provisions of I.C. 3-11-1.5-14.

BE IT FURTHER ORDAINED, that this Ordinance shall be effective on the date specified by the State Election Board in its order approving this Ordinance in accordance with the provisions of I.C. 3-11-1.5-24, or, if no date is specified, then this Ordinance shall be effective upon the first date permitted under the provisions of I.C. 3-11-1.5-25.

BE IT FURTHER ORDAINED, that each of the altered precincts shall have polling places which comply with the accessibility requirement adopted by the State Election Board.
