FLOYD COUNTY ORDINANCE- 1999-IX

WHEREAS, a petition for the vacation of a public place or way, pursuant to the provisions of I.C.36-7-3-12, has been filed with the Board of Commissioners of the County of Floyd; and

WHEREAS, due notice of the filing of such petition was given as required by the provisions of IC 36-7-3-12 (c); and

WHEREAS, pursuant to notice a public hearing was held on the 20th day of JULY 1999 and no person spoke in opposition to the proposed vacation.

NOW THEREFORE:

BE IT ORDAINED, that the following described public place or way or portion thereof, to-wit:

Beginning at the center of that part of Wolfe Cemetery Road no longer used by the Public and the South line of Lot Number 5, Plat No 1134, said point being on the North right-of-way line of Wolfe Cemetery Road as shown on Plat No. 1134. Thence running Northward along the center of said road to the Northernly line of Lot No. 5, Plat No 1134.

BE IT FURTHER ORDAINED, that the vacation of the public place or way described in this ordinance shall be subject to the rights of any public utility presently using all or any part of said public place or way.

BE IT FURTHER ORDAINED, that copies of this ordinance shall be delivered to the Recorder of Floyd County for recording and to Floyd County Auditor as requires by IC 36-3-7-12 (f).

TO: County Commissioners of Floyd County, Indiana


