

FLOYD COUNTY ORDINANCE FCO -XVII

AN ORDINANCE ESTABLISHING RATES AND CHARGES FOR SERVICES
RENDERED BY THE FLOYD COUNTY HEALTH DEPARTMENT

WHEREAS, the Board of Commissioners for the County of Floyd is empowered, pursuant to the provisions of I.C. 36-1-3, et seq., to establish reasonable rates, charges and fees for governmental services provided to the public; and

WHEREAS, the Floyd County Health Department has requested the establishment of fees and charges for medical and environmental services provided by the Department, as more particularly set forth in the Fee Schedules appended and marked Exhibit "A" and made a part hereof; and

WHEREAS, upon review, the Board of Commissioners of the County of Floyd has determined that the scheduled fees and charges do not exceed the administrative cost of those regulatory powers to be exercised or the cost of the services to be provided by the Department; and

WHEREAS, the Board of Commissioners of the County of Floyd is desirous of adopting by this Ordinance the Schedule of Fees to be charged by the Department for services rendered.

NOW THEREFORE:

BE IT ORDAINED, that the fees and charges set forth on the Fee Schedules appended hereto and incorporated herein be, and the same hereby are, adopted and established as the fees and charges to be levied and imposed for the various services to be rendered and performed by the Floyd County Health Department, with such fees and charges, upon collection and receipt, to be deposited by the Department as required by law.

BE IT FURTHER ORDAINED, that all previous ordinances adopted for the purpose of establishing rates and charges for services to be rendered and performed by the Floyd County Health Department be, and the same hereby are, repealed.

BE IT FURTHER ORDAINED, that this ordinance shall be in full force and effect after the date of its adoption, being the 21st day of AUGUST, 2001.

Floyd County Health Department Fees

Vital Records:

Birth Certificates.....	\$ 5.00 each copy
Death Certificates.....	\$ 5.00 each copy
Genealogy search.....	\$ 5.00 per name

Public Health:

PPD (T.B. Test).....\$ 4.00

Administration fee for all Immunizations provided by the
Indiana State Department of Health \$ 2.00

Flu Vaccine.....	Determined by Yearly Cost of Vaccine
Pneumonia Vaccine.....	Determined by Yearly Cost of Vaccine
Adult Hepatis B	Determined by Yearly Cost of Vaccine
All Other Adult Vaccines.....	Determined by Yearly Cost of Vaccine

Fees for vaccines are based on actual cost of vaccine to Health Department plus an administration fee of \$2.00 and will be raised as the cost to Health Department increases.

Maternal, Child Health Clinic

The charge for prenatal service and family planning services shall be a percentage of the actual cost thereof as determined by reference to the Federal Poverty Guidelines, as said actual cost and guidelines may be determined from time to time.
