AN ORDINANCE AMENDING FLOYD COUNTY.  
ORDINANCE 67-4 REGARDING BILLBOARDS

**WHEREAS** the Floyd County Plan Commission met on January 18, 2006 and adopted a resolution regarding billboards and in particular adopted a resolution regarding what ought to be considered a bill board, and

**WHEREAS** the Plan Commission proposed an amendment to the definitions section of a county ordinance commonly known as the Floyd County Bill Board Ordinance, more specifically "Floyd County Ordinance Number 67-4, Section 2.02," and

**WHEREAS** the Plan Commission proposed that Floyd County Ordinance Number 67-4, Section 2.02 be amended by inserting the following definition:

"Bill board" means any structure measuring more than 6' X 5' regardless of shape used as an outdoor display of any message or advertisement unless the structure is related to operations conducted on the premises where the structure is located."



**IT IS HEREBY ORDAINED** that Floyd County Ordinance Number 67-4, Sec 2.02 is hereby amended, inserting the following definition of a billboard:

"Bill board" means any structure measuring more than 6' X 5' regardless of shape used as an outdoor display of any message or advertisement unless the structure is related to operations conducted on the premises where the structure is located."


BILLBOARD means all structures measuring more than 6 feet by 5 feet regardless of shape, used as an outdoor display of any message or advertisement, unless the structure related to operations conducted on the premises where the structure is located.


